Chapter 1: Hardware Installation

1.1 Requirements

The following items are required for installation of your adapter:

- A ThinkSystem RAID 730-8i PCIe Adapter
- A host system with an available PCI Express (PCIe) expansion slot
- The *ThinkSystem Storage Adapter Software User Guide*
- Standard 12Gb/s SAS cables for connections to SAS/SATA drives, backplanes, or SAS expanders

1.2 Hardware Installation Instructions

To install your Lenovo adapter, follow these steps:

1. **Unpack the adapter, and inspect it for damage.** Unpack the adapter in a static-free environment. Remove the adapter from the antistatic bag, and carefully inspect the adapter for damage. If you notice any damage, contact Lenovo or your reseller support representative.

ATTENTION To avoid the risk of data loss, back up your data before you change your system configuration.

2. **Prepare the computer.** Turn off the computer, and disconnect the power cord from the rear of the power supply.

CAUTION Disconnect the computer from the power supply and from any networks, or you risk damaging the system or experiencing electrical shock.

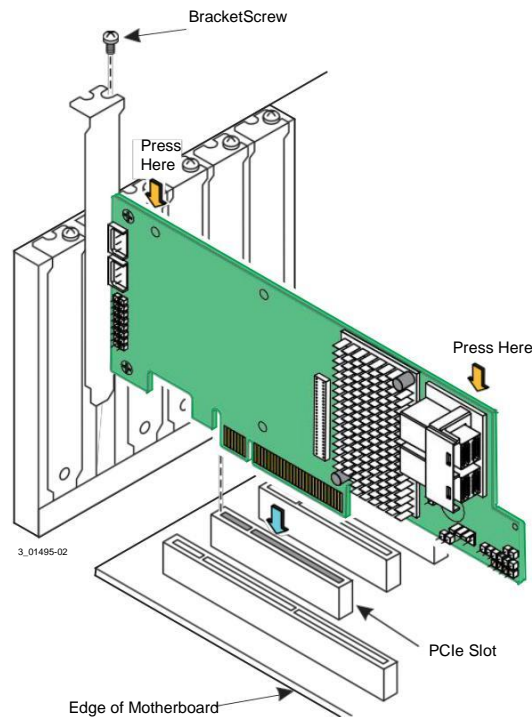
3. **Remove the cover from the chassis.**
4. **Check the mounting bracket on the adapter (system- dependent)** If required for your system, replace the full-height mounting bracket that ships on the adapter with the low-profile bracket supplied. Complete the following steps to attach the low-profile bracket.
 - a. Using a No.1 Phillips screwdriver that is ESD safe, remove the two Phillips screws that connect the full-profile bracket to the board. Unscrew the two screws located at the top and bottom edges of the board. Avoid touching any board components with the screwdriver or bracket.
 - b. Remove the full-profile bracket. Do not damage the adapter.
 - c. Place the adapter on top of the low-profile bracket. Position the bracket so that the screw holes in the tabs align with the openings in the board.
 - d. Using a No.1 Phillips torque screwdriver that is ESD safe, set to a maximum torque of 4.8 ± 0.5 inch-pounds. Replace the two Phillips screws removed in step a.

ATTENTION Exceeding this torque specification can damage the board, connectors, or screws, and can void the warranty on the board.

5. **Insert the adapter into an available PCIe slot.** Locate an empty x8 PCIe slot adequate for your adapter. Remove the blank bracket panel on the rear of the computer that aligns with the empty PCIe slot. Save this bracket screw, if applicable. Align the adapter to a PCIe slot. Press down gently, but firmly, to seat the adapter correctly in the slot. The following figure shows how to insert the adapter into a PCIe slot.

NOTE The shape, size, and locations of the components on your adapter and its bracket might vary from this illustration. The adapter requires an x8 PCIe slot.

6. **Connect SAS cables between the adapter and the SAS backplane or any other SATA device or SAS device.** Use cables with an external or internal mini-SAS HD connector on one end to connect to the adapter and the appropriate connector on the other end to attach to the backplane or the SAS/SATA devices. Connectors must be cabled to specific drive slots, as shown in the following table.

Connector	Drive Slots
C0	Drive slot 0-3
C1	Drive slot 4-7
C2	Drive slot 8-11
C3	Drive slot 12-15
C4	Drive slot 16-19
C5	Drive slot 20-23

7. **Replace the cover and reconnect any cords and cables, and power up the system.** Replace the chassis's cover, reconnect any power cords, and reconnect any network cables. Turn on the power.

8. Run the Human Interface Infrastructure (HII) Configuration Utility

Run the HII Configuration Utility to make any desired configuration changes. Refer to the *ThinkSystem Storage Adapter Software User Guide* for detailed steps on drive configuration.

The hardware installation of your adapter is complete.

1.3 Installing the Driver

This adapter can operate under various operating systems; however, you must install the software drivers. The firmware and drivers are routinely updated and made available on the Lenovo web site. Refer to <http://support.lenovo.com> for details on the software versions and device driver support.

Chapter 2: Overview

2.1 Overview

The ThinkSystem RAID 730-8i 2GB PCIe 12Gb adapter, based on the LSI SAS3108 RAID On-a-Chip (ROC) device, is a high-performance PCIe-to-SATA/SAS adapter.

Each adapter provides the following storage interface data transfer rates:

- SAS data transfer rates of 12Gb/s, 6Gb/s, and 3Gb/s per lane
- SATA data transfer rates at 6Gb/s and 3Gb/s per lane

The adapter negotiates between the speeds and the protocols to recognize and concurrently interface with any of these storage devices.

The following list summarizes many of the key features of the ThinkSystem RAID 730-8i PCIe adapter.

- Ports - 8 internal
- I/O processor - SAS3108 ROC device
- Form factor - LP-MD2
- Storage interface connectors - Two SFF-8643 x4
- Host interface - x8 PCIe 3.1
- Storage interface - SAS and SATA
- Cache Memory - 2GB

2.2 Functional Descriptions

2.2.1 PCIe Host Interface

The ThinkSystem RAID adapters have eight PCIe PHYs, which provide host-side maximum transmission and reception rates of 64 Gb/s (8 Gb/s per PHY). The RAID adapters use a packet-based communication protocol to communicate over the serial interconnect. Other PCIe host interface features include:

- Eight PCIe host lane interface
- Power management
 - Supports the *PCI Bus Power Management Interface Specification*, Revision 1.2
 - Supports Active State Power Management by placing links in a power-saving mode during times of no link activity
- Error handling
- High bandwidth per pin with low overhead and low latency
- Lane reversal and polarity inversion
- Single-phy (one-lane) link transfer rate of 8GT/s, 5GT/s, and 2.5GT/s in each direction
- Eight-lane aggregate bandwidth of up to 8 GB/s (8000 MB/s)
- Support of x8, x4, x2, and x1 link widths

2.2.2 SAS/SATA LED Operation

LED signals indicate an error condition or drive activity. SAS/SATA LED management is supported by SGPIO. The functionality is described in the SFF-8485 specification.

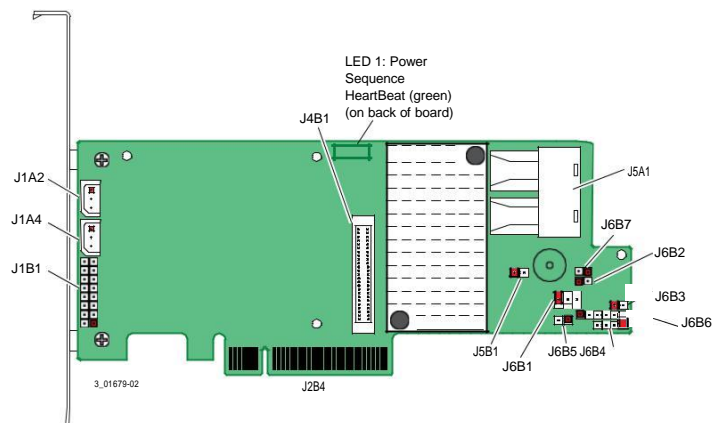
2.4 Adapter Characteristics

2.4.1 Board Layout, LEDs, Jumpers, and Connectors

The ThinkSystem RAID 730-8i adapter is a 6.127 in. x 2.712 in. (155.65 mm x 68.90 mm) board. The component height on the top and bottom of the adapter complies with the PCIe specification. This subsection provides the board layout, and the LED, connector, and jumper information for the adapter.

The following figure shows the LEDs, jumpers, and connectors on the adapter.

J1A2	IPMI-style I ² C connector for Ports 4 to 7	3-pin connector Supports SCSI Enclosure Services (SES) over I ² C through an internal I ² C backplane cable.
J1A4	IPMI-style I ² C connector for Ports 0 to 3	3-pin connector Supports SES over I ² C through an internal I ² C backplane cable.
J1B1	Individual PHY and drive fault indication header Ports 0 to 3 Ports 4 to 7	2x8-pin header Connects to an LED that indicates whether a drive is in a fault condition. One LED exists per port. When lit, each LED indicates the corresponding drive has failed or is in the <i>Unconfigured-Bad</i> state. The LEDs function in a direct-attach configuration (no SAS expanders exist). Direct attach is defined as a maximum of one drive connected directly to each port. NOTE The J5A1 connector on the RAID 730-8i adapter is a single internal port connector.
J2B4	Standard edge card connector	The interface between the adapter and the host system. Along with the PCIe interface, this connector provides power to the board and an I ² C interface connected to the I ² C bus for the Intelligent Platform Management Interface (IPMI).
J4B1	Child card connector	9-pin connector Connects the adapter to a child card.
J5A1	Dual x4 SAS Port 0 through Port 7 internal connector	Two SFF-8643 mini-SAS HD-4i internal connectors Connects the adapter by cable to SAS drives or SATA drives.
J5B1	Test header	2-pin connector Reserved for Lenovo debug.
J6B1	Reserved for Lenovo debug.	3-pin connector Reserved for Lenovo use.
J6B2	Default serial boot ROM (SBR) header	2-pin connector Reserved for Lenovo debug.
J6B3	Global hard disk drive (HDD) activity LED header	2-pin connector Connects to an LED that indicates activity on the drives connected to the adapter.
J6B4	On-board serial Universal Asynchronous Receiver/Transmitter (UART) connector	4-pin connector Reserved for Lenovo debug.
J6B5	Global drive fault LED header	2-pin connector Connects to an LED that indicates whether a drive is in a fault condition
J6B6	CPLD header	6-pin connector Reserved for Lenovo debug.
J6B7	Cache write pending header	2-pin connector. Connector for an LED mounted on the system enclosure. The LED indicates that the data in the cache has yet to be written to the storage devices.
LED 1	Power sequence heartbeat	Used for power-on and power-off sequencing.

2.5 Safety Characteristics

All ThinkSystem RAID adapters and HBAs meet or exceed the requirements of UL flammability rating 94 V0. Each bare board is also marked with the supplier name or trademark, type, and UL flammability rating. For the boards installed in a PCIe bus slot, all voltages are lower than the Safety Extra Low Voltage (SELV) 42.4V limit.
